In the winter, watering once every other week will give your lawn enough water. There is also no watering between the hours of 8AM and 6PM. If code enforcement sees anyone watering at that time they will issue you a ticket.

Everyone must also pick up after their dogs. Since we are a waterfront community it is even more important. The waste can go into the canals and the aquifer and foul our water supply.

The next meeting will be on the first Monday of March on the 2nd at 7 PM. We will have Jack Mariano, our county commissioner as our guest speaker. We will have a meet and greet party starting at 6PM, before the meeting. There will be

Leisure Beach Civic Association met March 2,2009 with Chuck Drago, President calling the meeting to order.

A getting to know your neighbor social was held prior to the meeting. Thanks to Terry Gedan and Marilyn Galli for the snacks and to Carol, Lena, and others for the cakes. A nice time was had by all.

Rich Galli reported that Tom from Code Enforcement issued a couple of summons and the issues have been resolved. Rich also stated that the Sheriff's Department has issued tickets for CARS PARKED ON THE STREETS. Tickets WILL BE ISSUED even if the car is ½ on the lawn and ½ on the street.

Carmen reported all had been quiet in Leisure Beach.

Beverlee Stabile reported that the median is in good shape. There are still some families not picking up after their dogs.

Jack Mariano, Pasco County Commissioner, was our guest speaker. He mentioned that if you install a new low flow toilet at a cost of about \$100 you could get a rebate from the county of up to \$80. Your water bill will also be lower becase of less water use. You must apply to the county before installing. He also mentioned that there would be a meeting at the Government Center on April 9th at 10 a.m. Regarding Wal Mart and the traffic problems. The Metropolitan Planning Board, DOT chief engineer and commissioners will be there. He advised that we have representation there and also to e-mail him with our concerns, a no-u-turn sign at Beach Blvd., a possible light at Tower and 19. His e-mail address is jmariano@pascocountyfl.net. The subject of recycling newspapers by the county is also being considered. Regarding the 2 new hotels on Route 19, no amusement park is being built. Pasco has had record revenue on taxes relating to tourism. Several other topics were covered.

Steve Byle stated that the County Attorney closed the case on 5th Isle regarding the dock situation. Jack Mariano is following through. He is looking to have another meeting with Leisure Beach, Steve, and Chuck. Elections will be held on April 6th. Anyone interested in holding a Board seat please see one of the officers. There are still some outstanding dues. Please send them in as soon as possible.

Meeting date April 6, 2009.

New officers were sworn in by Dale Mapstone.

Chuck Drago, President opened the meeting at 7:15 p.m.

The speakers were Pauline Smith, Supervisor and Tom Perozi, Code Enforcement Officers

Several topics were covered regarding Pasco County Codes:

- Watering hours effective April 3, 2009: All lawn watering remains limited to the same once-per-week schedule on their day. For lawns with sprinkler systems Midnight to 4 a.m. For properties less than one acre in size, using an in0ground irrigation system. 6-8 a.m. And 6-10 p.m. For properties of any size, using sprinkling cans, hand held hose equipped with automatic shut-off nozzle, o using a hose equipped with a portable hand sprinkler. Note: The same laws area may not be watered by multiple means, in other words, persons may no use and irrigation system and a hand held hose to water the same area twice or their day. New fines to be imposed: \$143.00 1st offense, \$263.00 2nd offense \$500.00 3rd offense.
- 2. House numbers shall be placed on a visible site from the street for emergency purpose. Numbers at least 3" high.
- 3. Parking on street overnight is not allowed. Unregistered cars must be in garage must be tagged if in front of house or there will be a fine.

4. When walking pets, they must be picked up after. Code violation.

5. Fences on waterfront property cannot be higher than 4 ft. and only chain link fences are allowed within 15 ft. of the mean high water line. For further restrictions contact code enforcement.

Several other subjects were discussed re: commercial vehicles, corner lot debris, docks, swimming pools, sunken boats and tall weeds. The question of barking dogs was brought up. It was stated that after 15 minutes of continuous barking it becomes a violation and Animal Control should be called.

Carmen said that all was going well as far as security goes.

The Community Garage Sale was a huge success for all participating.

Doris Mapstone said that dues are still coming in. If you have not paid yours NOW is the time.

PRESIDENT'S CORNER

Thank you to all of our members that voted to re-elect and install your New Board and Officers. All positions and phone numbers will be the same as last year.

Thank you to each of the Board and Officers for your continued service to our community.

We had a very good meeting with Pasco County Code Supervisor Smith and Code Offices Tom Pirozzi. Supervisor Smith explained the new water restrictions that will affect all of us. The new watering times on your watering day are 12:01 AM to 4AM. You can hand water from 6AM to 8AM or 6PM to 10PM on your watering days only. The fines will escalate from \$130.00 for the first offense, \$260.00 for the second to \$500.00 for the third. This does not include any court costs. So it pays to change your timers. The new code also eliminates power and car washing by individuals.

We just found out that permits are now required for all new docks even floating docks. Questions about watering or other codes can be answered by Pasco County Code Compliance Dept. at 727 847 8171. Or you can call 800 836 0797 ext 2298. Or look on the website at www.watermatters.org.

The testing of our water quality in the canals is back. The quality is very good. The two locations for the tests were Bear Creek at the end of Leeside and Fifth Isle at the end of Nautical.

THERE IS A MEETING AT THE COUNTY BUILDING ON LITTLE ROAD ON THURSDAY APRIL 24TM AT 1:30. THIS MEETING IS TO GRANT A VARIANCE TO ELIMINATE THE REQUIRED ONE ACRE PARK AT THE PROPOSED LEISURE BEACH TOWN HOMES ON FIRST ISLE. THIS WOULD MEAN THAT WITH NO OTHER PLACE TO PLAY, CHILDREN WOULD BE PLAYING ON THE STREET, WHICH IS DANGEROUS TO ALL. PLEASE ATTEND IF YOU CAN. STEVE BYLE WILL SPEAK FOR US.

We have some new signs on the medium, "PLEASE PICK UP AFTER YOUR DOG IT'S THE LAW". More signs will be here in June for the rest of the medium. Thank you to Steve Main, a new owner to Leisure Beach who is donating the signs.

Two of our members have volunteered their services for boat rescue. Since they have airboats they can get almost anywhere. They are Robert Clements and Tyler Clasen who can be reached at 352 279 3256. If they are called by you please remember that a donation towards gas money would be appreciated since they pay for everything out of their own pockets.

Treasurers report was read by Doris. A motion to accept was passed.

Water use is still restricted in Pasco county. Please make sure your sprinklers are off by 8:00 AM. During the winter months watering is only needed once every two weeks.

Someone illegally dumped hazardous waste into our sewer system which built up a dangerous amount of gasses. This required the county to flush out the system because of the danger of possible explosion. THIS WAS EXTREMELY DANGEROUS and almost caused an evacuation of Leisure Beach. If anyone sees this kind of activity please call 911, or a board member immediately.

We had 179 members in 2009, 2 more than in 2008. Thank you for supporting your community.

Rich Galli's report:

- There was a daytime robbery on Freeboard. They entered through the six foot slider in the back of the house. If you see any suspicious activity, please call 911. We are all neighbors.
- 2. A question was mailed to the county about the fence on 5th Isle coming up to the street line.
- 3. The trailer parked by the Eagles club is legal.

Please call Terry Gedan if you have any ideas for a speaker, non commercial, for our meetings.

A donation of \$300 to the Moose Club for the meetings was suggested and approved.

A wireless microphone will be purchased so those in the back of the room will be able to hear more easily.

The "pick up after your dog" signs donated by Steve Main seem to be working. The medium looks a lot cleaner. Thank you to owners for picking up. However, we have found there is one owner who is disregarding the signs. This large dog has been leaving deposits on the bike path between 2nd and 3rd Isles and is not being picked up. If you see the person who is not picking up, please notify someone on the board. Remember that this can ultimately end up in our water supply.

We noticed that the school bus pick up has been changed and is making several stops now in the community. That is great! If you have children that you are driving to the stop, please do not park your car on someone else's lawn. Lawns are considered private property and you could damage a sprinkler system, as well as the grass. Please park on the street. Thank you.
