### Presidents Corner

Our guest speakers at our February meeting were very informative. Officer Joe Zuccoli reminded us to lock our cars and not to leave keys in the ignition to deter anyone from stealing cash or other valuables. U-turns were again mentioned and Officer Zuccoli said they are trying their best to watch and ticket for them. As residents we feel a significant fine would help. Code Officer Nate Binford spoke about boats and trailers in driveways and debris around homes. Boats and trailers must be stored in the back of the house or on the side behind the front door line. Some residents have concerns about derelict docks and he said that the county doesn't have funding for dock removal, but the home owner could be sited for not keeping it in good repair for safety reasons. Several residents are wondering if they can put a roof over their docks. That is not

something he could comment on, but you can reach out to your county commissioners, one being Jack Mariano. You can email him at: [jmariano@pascocounty.net](mailto:jmariano@pascocounty.net). He also mentioned that seawall repair must be permitted and if replaced must be by a licensed contractor and even though riprap is not a solution that needs a license it still must be permitted and inspected by the county. Condemned homes was another topic of discussion. Officer Binford said that it takes a long time to get them removed. The condemnation process must go through many stages before anything can be done and could take several months or longer. See you at the March meeting! Ginny

He reported that he was not aware of the U-turn problem, which surprised us all. His unit works the night shift, but he said he would have them start monitoring the area and give tickets as needed. A question was asked about a Citizens unit. He reported the Citizen Service Unit consists of volunteers that help the police with issues, such as, parking citations, trespassing, and some minor accidents. **Information from the Fish and Wildlife Conservation Commission: Injured or Orphaned Wildlife.** When finding a baby animal, it is generally best to leave it alone. Often the animal is not orphaned, and the parent may be out getting food for the animal or watching the baby from a distance. Never pick up baby animals and remove them from their natural environment! When encountering injured wildlife, please contact the appropriate FWC licensed wildlife rehabilitator in your area. You can contact the FWC's Captive Wildlife Unit at (850)488-6253, or the appropriate Regional Office for local wildlife rehabilitator contact information. If the animal is a domestic or feral animal, such as a dog, cat or horse, please contact the nearest Humane Society, Animal Services Office, or Animal Control Agency.
