HIBISCUS ARE TOO BIG FOR THE ENTRANCE WE WILL MOVE THOSE. HOPEFULLY, WE WILL START THIS WORK THE END OF FEBRUARY. WE WILL NEED TO CHECK WITH PASCO FOR HEIGHT LIMIT ETC FOR THE SIGN BEFORE WE PROCEED WITH DESIGN IDEAS.

ONE OF OUR RESIDENTS SUGGESTED THAT MAYBE WE COULD MOVE OUR FLAGPOLE TO THE ENTRANCE. THAT THEN WOULD BRING ATTENTION TO THE ENTRANCE. ALSO SAID THE GUARD HOUSE LOOKS BETTER AND DOES PROVIDE A FALSE SENSE OF SECURITY THAT SOMEONE MONITORS THAT BUILDING. A FALSE SENSE IS BETTER THAN NOTHING.

THE KEEPING OR GETTING RID OF THE SECURITY CAR HAS HAD MUCH DISCUSSION FOR THE PAST YEAR. WHILE WE HAD VOLUNTEERS DRIVING IT, WE THOUGHT IT WAS WORTH THE FINANCIAL DRAIN. BUT FOR THE LAST SEVERAL MONTHS WE HAVE HAD NO VOLUNTEERS TO DRIVE IT AND IT NEEDED MANY REPAIRS. SO, THE SECURITY CAR WAS SOLD FOR \$900. WE ARE HOPING TO USE THAT MONEY TO REDESIGN THE ENTRANCE SIGN. NOW THAT THE CAR IS GONE THE BOARD IS LOOKING INTO GETTING MAGNETS THAT SAY NEIGHBORHOOD WATCH. AND ACTUALLY, SETTING UP THE NEIGHBORHOOD WATCH PROGRAM IN HERE. MAYBE AS AN ASSOCIATION WE COULD OWN A FEW MAGNETS THAT WE AS RESIDENTS CAN PUT ON OUR CAR WHEN WE FEEL LIKE DRIVING THE COMMUNITY. MIGHT SERVE AS A DETERRENT LIKE THE CAR DID. MORE RESEARCH IS NEEDED TO SET UP A NEIGHBORHOOD WATCH PROGRAM.

ON THE SUBJECT OF SECURITY GINNY BOUGHT UP THE SUSPICIOUS PEOPLE WALKING THROUGH THE COMMUNITY, SPEEDING CARS, ETC... HER QUESTION IS CAN WE REVISIT THE PROPOSAL OF INSTALLING A CAMERA

SYSTEM IN THE COMMUNITY. (THIS WAS DISCUSSED LAST YEAR THE COST WAS ABOVE \$5,000.) MANY RESIDENTS SAID WHEN THEY SEE ANYONE SUSPICIOUS THEY ASK IF THEY NEED ANYTHING AND USUALLY, THEY LEAVE. IT WAS SUGGESTED BY A FEW ATTENDING THE MEETING WE SHOULD ALL PUT THE NON-EMERGENCY PHONE NUMBER IN OUR CELL PHONES AND CALL THEM WHEN WE SEE SOMETHING THAT MAKES US FEEL UNCOMFORTABLE. IF YOU SEE SOMETHING REPORT IT. MOST RESIDENTS FEEL LIKE WE SHOULD WATCH OUT EVERYTIME WE DRIVE THROUGH AND THAT WEARING REFLECTIVE CLOTHING WHEN WALKING WOULD HELP WITH SEEING RESIDENTS IN THE DARK.

IT WOULD HELP IF SNOWBIRDS WOULD LET THEIR NEIGHBORS KNOW WHEN THEY ARE GONE SO THEY CAN KEEP THE PAPERS PICKED UP FOR THEM AND WATCH OUT.
